Mr. Knapp said that Ray Holtz from Nairy had worked with him and with Jim Ryan at BOCES. He said that they were well qualified and reputable. They use prevailing Wage rates. They will be using Epic Asbestos as a sub for asbestos removal. He recommended a 10% contingency fund. Hairy Mechanical is out of Union Hill, New York.
