MAYOR'S REMARKS

J.P. SCHEPP ON MAIN STREET WATER PROJECT

The final cost will be approximately \$208,000.00 which was within budget, however the engineering costs had an overage of \$8,690.30. There was a delay in the completion date from April 30 to May 30, 2014 when a Certificate of Completion was issued. There is however some grass seeding and finish work to be done. The Village is looking for the hydrants that were removed. A Motion was made by Trustee Scott and seconded by Trustee Frantz That:

\$30,605.20 should be paid on the project and the \$8,690.30 bill for engineering should be held back until it is determined all items on the punch list are completed. Some parts and hydrants need to be returned to the Village and the overrun issues are all addressed. The contractor is on the hook for a period of one (1) year for issues that may come up on the project.

NORTH MAIN STEET SIDEWALK PROJECT

J.P. Schepp will look at the area and give us an estimate and Russ Page will also look at it to see what it will take to remove the Asphalt.

FIREMANS REPORT

And to get what parts are needed.

RUSS PAGE ON PAVING

The Fence and broken step need to be removed. Russ also gave the board many options for paving at the community building, Trustee Scott and Trustee Constantino will go to the building with Russ Page after this board meeting and look at the parking lot and broken drains to determine what work needs to be done at this time. Russ Page will come up with some solid numbers for the July Board Meeting on milling and paving the lot. We will also be looking at the C.H.I.P money available to the Village for this work.

ZONING OFFICER

Zoning Officer Parsons stated that New York State (Deb Babitt) will be in to help with the zoning issues at the Christiano Hardware building permit. The cars are now gone from the property. The former JEDS Restaurant building needs to have weeds taken care of. Zoning Officer Parsons also stated that there are Courses available for the members of the Zoning Board and that he will be scanning the zoning laws onto a zip drive. The Village Zoning Board also needs a new member. The Village is also looking at what options are available for the blue building on Main Street with the new real-estate agent Bob Benson.
